NOTICE TO THE VESSEL S CALLING THE GRAND HARBOUR OF SIRACUSA REGARDING THE SECURITY AT "BERTH NR.5"

Dear Master/Sso

The Port of Siracusa comprises a large anchorage area where large cruise ships can stay during their Port call and a public berth : Berth Nr.5

Berth nr.5 is –at present- the only Port installation and the only ISPS and security interface Ship/Shore.

PORTO DI SIRACUSA SRL, has been entrusted to implement the requirements of the ISPS code within the Port areas assigned us and located in front of Berth nr.5.

Her main duty is to detect and prevent any possible illegal action against each ships at berth, her crew and the installation, their employees and all port operators. Our services includes but is not limited to permanent video surveillance, gate access watch, implementation of approved security procedures

The main objective to be achieved is :

-the complete and uninterrupted monitoring of the given Port areas in order to prevent unauthorized access to ships, port facility and their restricted areas during the all stay in Port of any ship.

The Port's Security level is currently : 1

For the above reason if Your vessel operates on same Level our PfsO will not issue a DOS (unless specifically requested by your Ship for specific reasons).

Complete security procedures will be available via your Agent or directly on our web site

For sake of opportune guidance we hereunder list the main procedures in force in our Port areas:

1. Siracusa berth nr.5 access gate is fitted with electronic badge reader.
2. Nobody is allowed to hold weapons/ammunitions and/or other dangerous material.
3. Only the authorized people will be admitted to transit
4. All crew and passengers must hold an official authorization in order to join or sign off from your ship (arranged by the attending agents).
5. All European crew going for shore leave must hold a valid transit pass (issued by Porto di Siracusa Srl) and handed over via Your Agent.
6. All crew being citizens of a Country for which Visa is required must hold a "Shore Pass" (arranged bu the attending Agent)
7. All transiting crew must hold a valid I.D. document (Passport) to be allowed to transit.
